OUR SPECIALTY IS PROVIDING LIFESAVING, HIGH QUALITY CARE FOR THE MEDICALLY VULNERABLE MEMBERS OF THE COMMUNITY THAT FALL BELOW THE POVERTY GUIDELINES. WE ESTABLISHED PAYMENT POLICIES BASED ON THE FLORIDA DEPARTMENT OF HEALTH POVERTY GUIDELINES. PATIENTS WITHOUT HEALTH INSURANCE AND INCOME BELOW 200% OF THE FEDERAL POVERTY GUIDELINES PAY NOTHING FOR CARE AND PATIENTS WHO DO NOT MEET INCOME GUIDELINES ARE PROVIDED CARE AT SIGNIFICANTLY REDUCED RATES. 67% OF THE POPULATION WE SERVE RECEIVE THEIR HEALTH SERVICES FOR FREE OR THEY ARE GIVEN A SLIDING SCALE. FREE CARE IS GIVEN TO VICTIMS OF HUMAN TRAFFICKING, DOMESTIC VIOLENCE VICTIMS AND FOR THE HOMELESS.

WE HIRED A MEDICAL DIRECTOR SO WE CAN BUILD A NETWORK FOR CREDENTIALING PURPOSES WITH INSURANCE COMPANIES. WHILE WE SPECIALIZED IN THE UNDERSERVED, WE ARE FINDING MANY PATIENTS THAT ARE INSURED WANT TO MAKE US THEIR PRIMARY CARE PROVIDER SINCE THEY HAVE HEARD SUCH GOOD REVIEWS OF OUR SERVICES.

WE INCREASED THE NUMBER OF DAYS WE WERE IN THE COMMUNITY FROM 2 DAYS A WEEK TO 5 DAYS A WEEK. IN ADDITION TO CONTINUALLY DOING COVID-19 TESTING, WE ADDED BREAST CANCER SCREENING AND PAP SMEARS TO OUR LIST OF SERVICES. WE ALSO PARTNERED WITH LABCORP TO REDUCE LAB WASTE.

ONCE THE INITIAL UPSURGE IN COVID BEGAN TO DISSIPATE AND WITH PROPER COVID GUIDELINES IN PLACE, WE WERE ABLE TO HAVE A SUCCESSFUL CAR WASH IN FEBRUARY OF 2021.

WE HELD A HEALTH AND FITNESS FAIR IN APRIL OF 2021. MULTIPLE HEALTH RELATED ORGANIZATIONS PARTICIPATED WITH US PROVIDING INFORMATION ON HEALTHY
